- Port Facility Inspector: prevented maritime transportation security incidents and marine casualties resulting from malicious acts, accidents or acts of nature against waterfront facilities; protected the public, critical infrastructures and minimized damage to the environment while limiting disruption to and supporting restoration of the Maritime Transportation System (MTS); developed and enforced federal marine safety, security and environmental regulations; reviewed facility security plans, facility response plans and operations manuals; conducted facility inspections for security, safety and environmental protection; inspected trade containers involving oil and hazardous substances; issued certificates of adequacy to facilities meeting standards receiving shipboard waste; supervised loading and unloading of explosive materials; and conducted training and outreach to federal, state, local, and industry personnel
- Emergency Medical Technician (EMT): provided out-of-hospital emergency medical care for search and rescue (SAR) and medical evacuation (medevac) patients, service members, or others encountered during missions; worked with emergency personnel to stabilize, monitor, and transport patients to best equipped hospitals for treatment; maintained emergency vehicle sanitation and medical supplies levels
- SAR Supervisor: coordinated, managed, and supervised assigned team searches and reconnaissance activities understanding team members capabilities and limitations; monitored adherence to all safety procedures; determined search and reconnaissance operational and logistical needs; reviewed briefings and situation reports and ensured keeping all search personnel informed of missions objectives and status changes; provided oversight for accountability, maintenance, and minor repairs for all issued/assigned equipment; completed operational period unit logs
